**Certified KAATSU Specialist Agreement**

In consideration of serving as a KAATSU Specialist I, for myself, my heirs, personal representatives or assigns, do hereby release, waive, discharge, and covenant not to sue KAATSU Global, Inc. ("KAATSU JAPAN"), its officers, employees, certified KAATSU Instructors, certified KAATSU Specialists, and agents from liability from any and all claims including the negligence of KAATSU GLOBAL, KAATSU JAPAN, its certified KAATSU Instructors, its certified KAATSU Specialists, its officers, employees and agents, resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, participation in leading or performing KAATSU Training.
